The Growth Pathway: Package Option B

The Operational Scaler (3 months)

This package is designed for businesses that have a clear vision but need assistance in developing the internal systems required for growth. It offers a more intensive and hands-on approach to establish the operational infrastructure necessary for scaling.

What's Included:

Operational Systems Audit: A full review of the client's current processes, tools, and workflows to identify inefficiencies and areas for improvement.

The Growth Pathway: Package Option C

The Strategic Partnership Retainer (minimum 6 month commitment)

This package is designed for Established businesses that have a functional system in place but need a consistent, expert advisor to help them navigate complex decisions, stay accountable, and continually optimise for growth.

What's Included:

Monthly Strategy Sessions: One two-hour strategic call per month to review KPIs, discuss new opportunities, and plan for upcoming challenges.

Payment Terms: The Growth Pathway

The Strategic Pivot (€2,500):

A 50% deposit of €1,550 is due upon signing service agreement to commence the program.
